7560. Apologies for absence.

Cllr Trevor Pilbeam, Cllr Heather Taylor, Cllr Alan Marsh, and Cllr Georgina Glover.

Cllr Bubb declared an interest in **7564 Planning**. Reference **CA/22/02523** – 64 Sweechgate Broad Oak Canterbury Kent CT2 OQU.

7561. To approve the minutes of the Parish Council Meeting held on 7th December 2022.

Cllr Isaac said that in the notes it stated administration rights had been given to Cllr Harriss and Cllr Isaac for the website but it should have been administration rights for Facebook. Also, some of councillors names were spelt incorrectly. Approval of the minutes was deferred until next meeting, after corrections have been completed.

7563. Finance.

a) To agree on the Parish Council budget for 2023/24

Cllr Davies asked if anyone had any questions about the 2022/23 accounts with 2023/24 projection. Cllr Bubb asked about the election expenses (Nominal code 4004). He asked why we had allowed £1500 for elections. It was pointed out that the elections are in May next year. He also asked why consultancy had gone up to £3450 (Nominal code 4017). This is to do with future major planning applications. In case we need to employ someone to assist as a consultant.

Cllr Bubb asked about the budget for Maintenance General (Nominal code 4023). Cllr Davies explained some of the increase might be due to coding. The coding is repetitious, over laps and they are being reviewed by herself and Cllr Harriss.

Cllr Bubb asked about the amount spent on IT (Nominal code 4045). It was agreed that this is high but will be reviewed in the new year.

Cllr Davies proposed agreement on budget figures for 2023/24 and Cllr Hogben second this proposal. All councillors agreed.

b) To Agree the parish precept for 2023/24.

The increase to £114888 is quite high but partly reflects the precept did not go up last year. Councillors were not happy for the precept to be raised to this amount and that some of the increase could be met from reserves. Cllr Bubb said £105,000 as next precept was about right.

He explained that need to earmark amounts. He also pointed out this has not gone up in the last 4 years. Cllr Davies proposed this and Cllr Bubb second this.

All councillors agreed.
