7795. Discussion & Approval of proposal to no longer offer "named" plots in Sturry Cemetery. Currently anyone purchasing an exclusive right of burial (ERoB), can select the plot they wish to purchase. Today, most Cemeteries operate a system, where an ERoB can be purchased, but the actual plot is allocated at the time the interment request is received. This proposal is (*other than for exceptional circumstances on a case-by-case basis*) to move to that model for all future ERoB purchases.

7796. Sturry Social Centre update and for decisionon the following items:

- a) How to administer the £40,000 contribution previously agreed by the parish council.
- b) Reclaiming V.A.T

In a previous meeting (14th June 2023) the Social Centre committee had requested that payments for modernisation work be made via the parish council's account in order to be able to reclaim the V.A.T. As the Parish Council owns the Social Centre premises this was considered by the Committee to be a legitimate request. At the meeting on the 14th June there was much confusion over what exactly the Social centre committee was asking for and there was a resolution not to pay the £11,000

contribution being made by the Social Centre. In fact no such funding had been requested and the Social is still committing £11,000 (or more) to this project.

The Committee would like to propose that the Parish Council pays for the three main items of work

Construction

New Flooring and

New kitchen

This will amount to approximately $\pounds40,000 \text{ ex V.A.T.}$ If due to price rises or unforeseen circumstances the total price is higher than this then the Social Centre will refund the parish council so that the parish council's total expenditure does not exceed $\pounds40,000$.

All other expenses have already been or will be covered by the social centre committee.

7798. Consultation over proposed development on the Pope's Lane Field

The parish council urgently needs to respond to the planning application for 110 homes for the Popes Lane site.

For decision:

An application from the parish council for an extension of time to enable the PC to fully consult with residents.

To agree a budget of no more than £500.00 to cover the cost of printing leaflets, exhibition material and venue. A member of SABORA has volunteered to provide the artwork for leaflets et. Free of charge and members will also help to distribute leaflets and assist with the meeting, it has a only a small budget but is willing to cover some of the cost.
